**COURSE AND BIRDS:** Quail will be released in all stakes. Native birds may be present. A blank cartridge will be fired in all stakes. Shotguns with Blank Shells not permitted. Please mark entries if you intend on handling on foot for either the National or National Amateur Championships.

All stakes **45 MINUTES** on a single course without a bird field.

**NATIONAL CHAMPIONSHIP & NATIONAL AMATEUR CHAMPIONSHIP STAKES:** Open to any AKC registered English Setter, six months of age and over on the first advertised day of the trial, which has placed first, second, third, or fourth in any Open Gun Dog, Open Limited Gun Dog, Amateur Gun Dog, Amateur Limited Gun Dog Stakes, Open All-Age Stake or Amateur All-Age Stake at an AKC licensed or member field trial or have earned an AKC Master Hunter Title. The National Championships will be a 45-minute single course without bird fields.
